## TARGET OF USD 5 BILLION FDI 'FAR FETCHED'

Sri Lanka's sluggish progress in privatising State-Owned Enterprises (SOEs), rigid labour market regulations, and restrictions on foreign participation continue to undermine investor confidence, the U.S. State Department warned in its 2025 Investment Climate Statement.

According to the report, 527 SOEs, including 55 classified as strategic, continue to strain public finances and crowd out private sector activity. The previous administration had launched a reform drive aimed at restructuring and partially privatising major loss-making enterprises.



However, the current government halted those privatisation efforts upon taking office, opting instead for internal restructuring measures focused on cost-cutting and improved governance within existing state ownership.

The report observed that the suspension of privatisation, particularly at the Ceylon Electricity Board (CEB), has slowed energy sector reform, keeping electricity prices high and discouraging industrial competitiveness.

"Foreign investors consistently face high transaction costs, unpredictable policy shifts, and opaque procurement procedures," the statement said, noting that uncertainty continues to weigh heavily on Sri Lanka's investment prospects.

Despite these setbacks, the report acknowledged several enduring strengths. Sri Lanka allows 100% foreign ownership in most sectors, offers constitutional guarantees for investment protection, and ensures full repatriation of profits and capital.

The Colombo Stock Exchange recorded \$66.5 million in net foreign inflows in 2024, raising a total of \$568 million in capital. Worker remittances surged to \$6.58 billion, boosting foreign reserves to \$6.1 billion by the end of the year.

Export Processing Zones continue to attract investors, while newer ventures such as the Hambantota pharmaceutical zone and Colombo Port City are expected to open fresh opportunities.

Yet, the Economic Transformation Act, which aimed to streamline approvals by replacing the Board of Investment with five specialised agencies, remains unimplemented leaving investment approvals fragmented and slow.

The report cited uneven tax treatment, corruption in procurement, and bureaucratic inefficiencies as persistent obstacles. It highlighted the government's decision to impose new taxes on service exporters while offering exemptions to Port City firms, reinforcing perceptions of policy inconsistency.

Labour rigidity was flagged as a key constraint. Strict dismissal laws have made restructuring costly, while labour shortages have intensified due to emigration, particularly in the IT, apparel, tourism, and engineering sectors. The garment industry, the report noted, faces turnover rates as high as 40%, compounded by limited social protection for informal workers.

Although Sri Lanka recorded 5% GDP growth in 2024, surpassing expectations, foreign direct investment (FDI) remains weak. Most deals are small, ranging from \$3–5 million, concentrated in tourism, ICT, renewable energy, and real estate.

The government's pledge to finalise Sinopec's \$3.7 billion oil refinery in Hambantota could become the largest FDI in history, but investor confidence suffered when Adani Green Energy withdrew from a \$400 million wind project after renegotiation attempts.

Land restrictions also limit foreign participation, with companies holding over 50% foreign equity barred from purchasing land. Sectoral caps of 40% apply to agriculture, shipping, and education, while areas such as small retail and coastal fishing remain off-limits.

The report concludes that Sri Lanka's ability to attract investment hinges on converting recent macroeconomic stability into genuine reforms. Without progress in governance, regulatory simplification, and labour flexibility, the government's ambitious \$5 billion FDI target for 2025 is unlikely to be met.

## CHINA AND INDIA RESTART DIRECT AIR SERVICES

India and China have agreed to resume direct flights as ties normalise following five years of tensions after the Galwan clashes. Airline IndiGo announced that it will resume the direct flights from October 26.

IndiGo's announcement came shortly after the Ministry of External Affairs announced that the two countries have reached an agreement.



Since earlier this year, as part of the Government's approach towards gradual normalisation of relations between India and China, the civil aviation authorities of the two countries have been engaged in technical-level discussions on resuming direct air services between the two countries and on a revised Air Services Agreement."

The flights were suspended in the aftermath of the <u>Doklam crisis</u> and further delayed due to the Covid-19 pandemic

## Sri Lanka CIABOC probing four proceeds of crime cases

Sri Lanka's Commission to Investigate Allegations of Bribery of Commission working on four cases under the island's newly passed proceeds of crimes law, its Director General Ranga Dissanayake said.

A hotel and some houses said to be owned by officials are being investigated, he said without elaborating. Under the law, the state can confiscate assets which the holders cannot explain how they acquired on the principle of 'balance of probabilities' without proving 'beyond reasonable doubt' as in criminal cases.

A suspect has to explain how they came about the assets to prevent them being confiscated.



The state can confiscate asset which cannot be explained away, without convicting the person of a crime.

The CIABOC is receiving large numbers of complaints from the public and there was also a backlog of old cases, but the agency is unable to recruit officers to investigate them after a fiscal rule blocked the expansion, he said.

The CIABOC is working on a list of 'Grand Corruption' and Politically Exposed Persons (PEPs), he said.

The list was prepared by the Commission before he was hired as the director general.

#### OPPOSITION PUSHES FOR FORENSIC **AUDIT ON 'IMMIGRATION SCAM'**

Opposition lawmakers are intensifying calls for the public release of the forensic audit into Sri Lanka's controversial e-visa contracts, even as a new "special audit" is poised to reach the Parliamentary Committee on Public Finance (COPF) within days. Their renewed demand came in the wake of a Supreme Court judgment on Tuesday, which sentenced former Controller General Immigration and Emigration Harsha Ilukpitiya to two years' imprisonment for contempt of court. The court found he had failed to comply with an earlier order to reinstate the old visa system pending final adjudication of petitions challenging the new e-visa scheme.

Despite more than 15 months having passed since the petitions were filed, opposition critics assert the government has yet to submit the forensic audit to the Supreme Court as required.

The lawsuits were lodged by Opposition politicians Patali Champika Ranawaka, M.A. Sumanthiran, and Rauff Hakeem, all of whom served on the COPF at the time the e-visa deal was scrutinised. Ranawaka has emphasised that while the contempt case was concluded on September 23, 2025, the substantive challenge to the e-visa system is still pending. The next hearing is slated for November



At the heart of the dispute lies the stalled forensic audit, the principal recommendation of a 660-page COPF report which Parliament approved in July of last year, authorising the Auditor General to carry out a full review of the procurement process.

The petitioners themselves have preliminary loss calculations to the court. They estimate that Sri Lanka lost Rs 3.71 billion between the introduction of the new system (April 17, 2024) and the issuance of an interim court order, owing to the shift from a US\$1 visa-processing charge to one

An additional Rs 4 billion, they claim, was lost because the interim order was not enforced and the old system was not reinstated. Support for these figures comes from data showing that the

US\$12.6 million (around Rs 3.78 billion) between liberation hero Nelson Mandela's grandson, Nkosi April and August 2024.

Ranawaka insists that only a forensic audit by the Auditor General can establish an official, courtaccepted figure for losses. Without it, he argues, their estimates carry only persuasive weight. "If the audit officially confirms fraud and quantifies the loss, any citizen may file complaints with the police or the Bribery Commission," he said. He has further alleged that the audit report is being withheld to obstruct criminal deliberately proceedings.

In recent days, however, the government has moved to deflect mounting pressure by announcing a "special audit"distinct from a full forensic auditas the Auditor General reportedly declined to conduct full forensic work. According to Minister of Public Security Ananda Wijepala, this special audit has already been sent to the Immigration Department for review and is expected to be forwarded to the COPF within a week.

With mounting public scrutiny and political pressure, the COPF is expected to notify Parliament of next steps once it receives the audit report.

Meanwhile, in parliament, MP Rauff Hakeem has also called for the forensic report's formal submission to parliament, pointing to a COPF directive for the Auditor General's involvement. Hakeem has accused the government of failing to await the forensic audit and said losses could amount to as much as US\$3.4 billion.

In sum, opposition parties now face a pivotal moment. They must decide whether to accept the special audit as a compromise or to press ahead in court for the original forensic audit, pushing to unmask the full extent of alleged malfeasance in Sri Lanka's visa contract process.

Gaza latest: Protests erupt around world after Israel detains Greta Thunberg on aid

## It's Official: Shah Rukh Khan is a billionaire

The legendary Bollywood superstar Shah Rukh Khan has joined the billionaire club, becoming the richest entertainer in India with a fortune estimated at \$1.4 billion, according to the Hurun India Rich List 2025.



Khan, 59, amassed a net worth of more than 12,490 crore rupees through a combination of blockbuster films, global endorsements, production ventures and ownership of the Indian Premier League franchise Kolkata Knight Riders.

It is the first time a Bollywood actor has entered the billionaire ranks, marking a milestone for the Indian film industry.

Khan's wealth surpasses that of several international entertainers, including American singer Taylor Swift, media reports said.

The actor, often dubbed the "King of Bollywood," continues to generate revenue from his production house Red Chillies Entertainment, long-running brand deals and high-grossing films such as last year's Jawan.



He also won his first National Film Award this year, adding to a career that spans more than three decades.

Despite his new billionaire status, Khan does not feature among India's top 100 wealthiest individuals, a list dominated by industrialists such as Mukesh Ambani and Gautam Adani.

Khan's entry into the billionaire club underscores the growing global clout of Indian cinema and its leading figures.
